Extended Day Care:

Early morning care from 7:00 a.m. to 7:35 a.m. is offered at no charge for students in grades K-8. Pre-Registration is not required for AM or PM care. Monthly billing through FACTS. Prepayment per semester at discount rate available. (TBD) There is no Extended Day Care on 11:10 a.m. early dismissal days or emergency (snow) days. Child-care is tax deductible.

Grades 1–8th Hours 2:30 p.m. to 5:30 p.m.:

One child - \$13.00 per hr., Two children - \$18.00 per hr., Three children - \$23.00 per hr.

PreK 3/4/5 only 7:30-8:30 a.m.; PreK 3/4/5 & K 2:30-5:30 p.m. - \$15.00 per hr.

* Additional Annual fees (non-refundable, not applied to tuition):

Registration /Parent Association (HSA) Fees - \$300 per family

Graduation Fee - \$100 for 8th graders

Volunteer Hours -30 hours per family with a student in Grades K-8; 15 hours per family with a student only in PreK 3/4/5. Option to pay \$20 per hour not served.

Parish rate families require annual confirmation from the pastor that they are active and contributing members of their parish by completion of the Parish Affiliation Form provided.
